

# Job Description Consultant: Adolescent Health Field Coordination Human Resources for SRH and SGBV in South Sudan

#### **TECHNICAL ACTIVITY**

The Canadian Association of Midwives wishes to recruit one **Adolescent Health Field Coordinator** to support creation and co-ordination of various materials and activities relating to Sexual Rights and Reproductive Health issues affecting youth. The role would involve 5 to 7 days of coordination work per month to help liaise with project partners, suppliers, and other stakeholders located in Juba, South Sudan. The activities are part of the Global Affaires funded, UNFPA-led Human Resources for SRH and SGBV in South Sudan.

**Timeframe:** 11 months, February – December 2023 **Location**: Juba, South Sudan **Remuneration:** Maximum \$7700 USD

### A. About the Canadian Association of Midwives

The Canadian Association of Midwives (CAM) is the national professional association representing midwives and the profession of midwifery in Canada. Since 2008, CAM, through its Global Program, has been working through partnerships with other national midwifery associations in Africa and Haiti to deliver reciprocal capacity building and improve reproductive health outcomes. CAM has been working in South Sudan since 2007 through various Global Affairs Canada (GAC) funded initiatives including the Strengthening Midwifery Services Phase II project, the SMART-RMC project, and the Human Resources for SRH and SGBV in South Sudan project.

### **B. Project Background**

The Global Affairs Canada-supported and UNFPA-led Human Resources for SRH and SGBV in South Sudan project is aimed at increasing realization of the sexual and reproductive health and rights of women and girls in South Sudan, particularly those who are left behind including women and girls in vulnerable situations, those in displaced camps and humanitarian situations; women and girls living with disabilities, and those living with HIV. The project will focus on four key components:

- Strengthening the provision of quality integrated SRH/GBV/HIV services.
- Increasing awareness among women, girls, men, and boys to utilize gender responsive SRH/GBV/HIV services.
- Strengthening health training institutions to produced quality human resources for SRHR/GBV/HIV services; and
- Improving national and state government capacities to develop and implement SRH/GBV/HIV policies, legislations, and coordination mechanisms

# **C. Role and Objectives**

### **Objectives:**

In collaboration with CAM-Global Communications Co-Ordinator and other relevant stakeholders:

1. Support the development of relevant programming content for the Zone 72 talk show

- 2. Attend production meetings (bi-monthly or monthly TBC)
- 3. Provide insight and feedback about potential guests, confirm presence of guests
- 4. Support the content creation and co-ordination of materials for youth, including but not limited to:
  - a. reviewing materials to ensure authenticity of content and voice
  - b. support the development of ideas
  - c. support co-ordination of and participate in relevant agreed upon review sessions with other stakeholders
- 5. Support with necessary permissions from certain stakeholders including but not limited to:
  - a. permissions from the Media Authority
- 6. Support in the creation and co-ordination of any public facing events

# D. Methodology / Approach

## 1. Parties involved

During the assignment, work and collaboration will occur between the following actors:

- a. CAM-Global Communications and other appropriate CAM staff
- b. Eye Media
- c. South Sudan Media Authority
- d. Other stakeholders and participants

## 2. Level of Effort

The level of effort (LoE) reflects a total of five to seven full days of work per month with specific activities documented in a monthly activity report. The total is approximately 55-77 days over the course of 2023.

# E. Remuneration

The Consultant will be remunerated for their services based on payable amounts for the activities according to the deliverables schedule, as discussed and agreed with CAM upon contract signing. The full contract will be no more than \$7700 USD at a rate of \$100 USD/day.

# F. Qualifications

- Minimum two years of experience in project co-ordination or project management or educational equivalent.
- Excellent communication skills
- Strong and demonstrated reporting skills
- Demonstrated knowledge and understanding of the complexities of Sexual and Reproductive Rights and Health, especially regarding the rights of women and girls and marginalized populations
- Experience working with an international NGO an asset
