

The Midwifery Group is seeking a Locum Position

Our Clinic:

The Midwifery Group is a busy and supportive midwifery practice located in a beautiful store-front location on Main Street in Vancouver, British Columbia. Established in 1998, we have a strong presence in our community and relish the diversity of our clientele. We believe in supportive and sustainable models of sharing call and are keen to experiment with models of midwifery care that support our individual midwives to have rewarding careers, and maintain a healthy work-life balance. We enjoy our work and we enjoy each other's company.

Midwives on the team have hospital privileges at BC Women's Hospital and have about a 25% home birth rate. We offer full-time administrative support and use an electronic medical record (Oscar) to provide safe and coordinated client care in a team-based midwifery model. Our clinic currently operates with two teams of midwives that meet regularly for clinic meetings and support each other.

The Position:

We are seeking one Registered Midwife to cover a locum position for one of midwives who requires a medical leave. We would also consider a new graduate of an accredited midwifery program. The locum would be working with a team of 4 enthusiastic, hard-working and supportive (and fun!) midwives, with a full-time clinical practice. As we are a larger team, we have developed a schedule that supports work-life balance by offering 24-hour call shifts. The applicant must be eligible to apply for locum hospital privileges at BC Women's Hospital Department of Midwifery to be registered for the July 1st start date. Ideally, starting to meet clients in June 2018 and starting call shifts in July 2018.

*There is some flexibility to this start date. If you are available for a more short-term arrangement, alternatively, we can consider the locum arrangement be a fulltime position for:

1. The month of August 2018 as long as the midwife applying had the ability to meet clients in clinic in July 2018 to establish continuity OR
2. Both July and August 2018 (as long as the midwife had the ability to meet the clients in June 2018).

The applicant would need to be:

- Eligible for registration with the College of Midwives of BC and the Midwives Association of BC by July 1, 2019 or sooner.
- A strong communicator with experience working in a team-based environment
- Committed to providing exemplary midwifery care
- Experienced in providing care to diverse families

- Highly responsible
- Experience working with electronic medical records (such as OSCAR) is an asset but not required as training can be provided.
